### **Position Available**

The <u>DC Appleseed Center for Law and Justice</u> ("DC Appleseed") seeks a part-time legal policy intern for Spring 2026. Students interested in policy and advocacy work are encouraged to apply. We are especially interested in candidates who are passionate about or interested in one of our project areas.

### **Organization Description**

DC Appleseed makes the District of Columbia a better place to live and work through advocacy, policy, oversight, strategic partnerships, and litigation. For over 30 years, DC Appleseed has focused on issues that touch nearly every aspect of public life in the District, particularly issues impacting historically marginalized people who live and work in the nation's capital. Our projects revolve around at least one of our three foundational pillars: Racial Equity, Economic Mobility, and Democracy & DC Autonomy.

Current project topics include health equity (sexual and reproductive health, behavioral health, and environmental justice/climate change mitigation), democracy and DC autonomy, gun violence reduction, and workforce development related to the long term care workforce.

## **Position Responsibilities**

Project assignments are based on the organization's needs and the intern's interests. Depending on the topic and timeline of a particular project, the intern's responsibilities may include:

- Conducting legal and/or policy research and writing memoranda summarizing findings;
- Identifying and researching best practices (either legislative, regulatory, or policy positions) that other jurisdictions have successfully implemented to address problems that our project teams are considering;
- Attending and reporting on community outreach efforts and various public meetings and hearings;
- Assisting in preparing legislative briefing materials, one-pagers, and hearing testimony;
- Attending and participating in coalition meetings with other District stakeholders;
- Attending and participating in project team meetings with pro bono partners; and
- Other legal and policy work as needed.

## **Position Logistics:**

- DC Appleseed is currently in a hybrid work format, working remotely on Mondays and Fridays and in the office Tuesday—Thursday.

- Ideally, the candidate will work 15-20 hours a week, with at least one day or a portion of one day in the office. Hours can be flexible between 9 AM and 6 PM.
- The start and end dates are flexible based on the school semester schedule and course requirements, but a roughly 10 —12-week commitment is requested.
- Flexibility for holidays and school breaks.

- Experience or interest in a research, advocacy, or policymaking environment.
- Agility and ability to pivot in response to current events and revised priorities.
- Flexibility, creativity, and initiative, along with excellent organizational, planning, and project management skills.

### **Compensation & Benefits**

This position is unpaid and not eligible for benefits, but DC Appleseed will work with the candidate to secure academic credit and/or public interest funding for their work with us.
